**NOTICE CLOSING CASES**

On September 9, 1999, MCI WorldCom Communications, Inc. (MCI), and Brooks Fiber Communications of Missouri, Inc. (Brooks), each filed a formal complaint against Southwestern Bell Telephone Company (SWBT). These complaints were numbered TC-2000-225 and TC-2000-226, respectively. By order issued on October 14, 1999, the Commission consolidated Case No. TC-2000-226 into Case No. TC-2000-225 for all purposes.

On October 21, 1999, BroadSpan Communications, Inc., doing business as Primary Network Communications, Inc. (PNC), filed another formal complaint against SWBT. The Commission assigned number TC-2000-294 to this complaint, which was essentially identical to those previously filed by MCI and Brooks and was filed by the same attorney. The Commission consolidated Case No. TC-2000-294 into Case No. TC-2000-225 for all purposes by its order issued on December 7, 1999.

On October 6, 2000, the parties jointly filed their Notice of Dismissal of Case Nos. TC-2000-225 and TC-2000-226 and Joint Status Report on Case No. TC-2000-294. Therein, the parties agreed to dismiss Case

Nos. TC-2000-225 and TC-2000-226 with prejudice and advised the Commission that the remaining case, Case No. TC-2000-294, was in the process of settling and that resolution was expected before the end of October. Pursuant to Rule 4 CSR 240-2.116(1), a case may be dismissed voluntarily after testimony has been filed upon the written consent of the parties.

Cases TC-2000-225 and TC-2000-226 may now be closed. Any proceedings regarding the remaining case should be filed under its number, TC-2000-294.

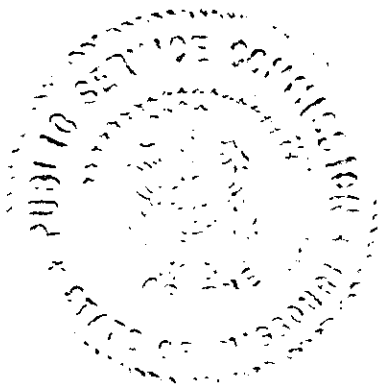
