COMES NOW, BroadSpan Communications, Inc. d/b/a Primary Network Communications, Inc. (PNC), by and through its attorneys pursuant to 4 CSR 240-2.080 and for its Motion to Consolidate states:

- 1. On or about October 21, 1999, PNC filed the above referenced complaint with the Commission against Southwestern Bell Telephone Co. (SWBT).
- On or about September 10, 1999, MCIWC filed a similar complaint with the Commission against SWBT, which was docketed as Case No. TC-2000-225.
- 3. On or about September 10, 1999, Brooks Fiber Communications of Missouri, Inc. (Brooks) also filed a similar complaint against SWBT, which was docketed as Case No. TC-2000-226, and subsequently consolidated with Case No. TC-2000-225.
- 4. All three complaints deal with the same subject issue, to wit: failure of SWBT to remit reciprocal compensation to complainants under their interconnection agreements for calls placed by SWBT's customers to complainants' ISP customers.
