ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY AND TARIFF
AND CLOSING CASE

On June 20, 2000, KCI Long Distance, Inc. (KCI) filed its application to cancel its certificate of service authority. KCI stated that it is requesting the Commission to cancel its certificate of service authority because KCI does not intend to provide telecommunications services in the state of Missouri in the future because of a change in business plan. KCI stated that the Commission granted its certificate of service authority to provide interexchange telecommunications services in Case No. TA-98-105 on November 19, 1997.

The Staff of the Public Service Commission (Staff) filed its recommendation on June 26, 2000. Staff confirmed that KCI was granted its certificate of service authority to provide interexchange telecommunications services on November 19, 1997, in Case No. TA-98-105. Staff stated that KCI does not currently serve any interexchange customers in Missouri and has no plans to serve customers in the future. Staff recommended that the Commission issue an order canceling KCI's certificate of service authority and accompanying tariff at its earliest convenience. Staff further stated that it is


unaware of any other filing that affects or would be affected by this proposal. Staff confirmed that KCI does not owe the Commission any assessment fees.

The Commission has reviewed the application from KCI and Staff's recommendation, and finds that it would be in the public interest to cancel a certificate of service authority to provide interexchange telecommunications services for a company which no longer wishes to transact business in the state of Missouri. The Commission will grant KCI's application to cancel its certificate of service authority, and upon Staff's recommendation, will also cancel KCI's accompanying tariffs.

IT IS THEREFORE ORDERED:

1. That the certificate of service authority granted to KCI Long Distance, Inc. on November 19, 1997, in Case No. TA-98-105, along with its accompanying tariffs, is canceled.
2. That this order shall become effective on October 10, 2000.
3. That this case may be closed on October 11, 2000.

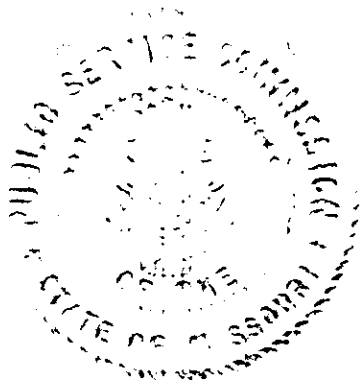
