

ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY AND TARIFF AND CLOSING CASE

On June 20, 2000, FaciliCom International, LLC (FaciliCom) filed its application to cancel its certificate of service authority to provide interexchange telecommunications services. FaciliCom stated that the Commission granted it a certificate of service authority to provide interexchange telecommunications services in Case No. TA-98-323 on April 27, 1998. FaciliCom requested the Commission cancel its certificate of service authority because FaciliCom does not intend to provide telecommunications services in the state of Missouri in the future based upon a change in business plan.

The Staff of the Public Service Commission (Staff) filed its recommendation on June 26, 2000. Staff confirmed that FaciliCom was granted its certificate of service authority to provide interexchange telecommunications services on April 27, 1998, in Case No. TA-98-323. Staff stated that FaciliCom does not currently serve any interexchange customers in Missouri and has no plans to serve customers in the future. Staff recommended that the Commission issue an order canceling FaciliCom's certificate of service authority and accompanying tariff. Staff stated that it is unaware of any other

filing that affects or would be affected by this proposal. Staff also confirmed that FaciliCom does not owe the Commission any assessment fees.

The Commission has reviewed the application and Staff's recommendation, and finds that it would be in the public interest to cancel the certificate of service authority and tariff of FaciliCom. Therefore, the Commission will grant FaciliCom's application to cancel its certificate of service authority, and based upon Staff's recommendation, the Commission will cancel FaciliCom's accompanying tariff.

IT IS THEREFORE ORDERED:

1. That the certificate of service authority granted to FaciliCom International, LLC on April 27, 1998, in Case No. TA-98-323, along with its accompanying tariffs, is canceled.
2. That this order shall become effective on October 10, 2000.
3. That this case may be closed on October 11, 2000.
