

NOTICE CORRECTING SUSPENSION DATES NUNC PRO TUNC

On May 18, 2001, Laclede Gas Company submitted revised tariff sheets to the Commission reflecting increased rates for natural gas service with a proposed effective date of June 18, 2001. On June 7, 2001, the Commission issued its Suspension Order and Notice suspending the tariff sheets for 120 days plus an additional six months. The order incorrectly stated the dates of the suspension period. Pursuant to Section 393.150, RSMo 2000, the 120-day suspension period runs from the proposed tariff effective date of June 18, 2001, to October 16, 2001, and the six-month suspension period runs from October 16, 2001, to April 16, 2002. See, pages 1, 4 and 5 of the Suspension Order and Notice. Ordered paragraphs numbered 1 and 2 incorrectly state the suspension dates.

All interested parties should take notice that the gas service tariff sheets presented in this case are suspended through April 16, 2002, unless otherwise ordered by the Commission.


