COMES NOW OnFiber Carrier Services, Inc., ("OnFiber" or "Applicant") and hereby states
as follows:

1. OnFiber initiated this proceeding on April 28, 2000, by filing an Application requesting a certificate of service authority to provide basic local and local exchange and intrastate interexchange telecommunications services in exchanges currently served by Southwestern Bell Telephone Company ("SWBT"), Sprint/United Telephone Company ("United") and GTE Midwest, Inc. ("GTE"), in the State of Missouri.

2. OnFiber has determined that it will not currently seek authority to offer or provide basic local exchange service. For that reason, it wishes to amend its Application to delete all reference to the request for authority to provide basic local exchange service.






