- 1. On October 25, 2018, several parties to this proceeding submitted the *Stipulation* for the Commission's approval. The Missouri Public Service Commission ("Commission") approved the *Stipulation* on December 5, 2018. Among the other provisions contained in the *Stipulation* and approved by the Commission is the requirement for the parties to this case to engage in collaborative discussions to explore additional opportunities for energy efficiency savings.
 - 2. With regard to the collaborative activities, paragraph 11 of the *Stipulation* states:
 - Collaborative Meetings to Explore Additional Opportunities. No later than June 1, 2020, Ameren Missouri will file in this docket a report summarizing collaborative discussions between the Signatories similar to its MEEIA 2016-2018 Collaborative Report. The objective of this collaborative effort is to systematically explore additional savings opportunities with the intention to impact possible changes to MEEIA 2019-21 programs and/or to provide a foundation for new and/or modified programs for a proposed MEEIA Cycle 4. The Company will host at least four meetings, with no more than six months in between the meetings....
- 3. Ameren Missouri engaged stakeholders in person and via email through various exploratory efforts during 2019 as detailed in the attached *Collaborative Report*, which the

Company now files the *Collaborative Report* with the Commission, consistent with the terms of the *Stipulation*.
