

APPLICATION FOR CANCELLATION OF CERTIFICATE AND TARIFF

Comes Now LECNet, inc. (LECNet), by its undersigned counsel, and pursuant to § 392.460 RSMo., hereby requests the cancellation of LECNet's certificate to provide competitive interexchange telecommunications services within the State of Missouri and LECNet's interexchange tariff. LECNet has no local exchange customers in Missouri, so the cancellation of LECNet's certificate will not affect any Missouri telecommunications customers or otherwise be contrary to the public interest. In support this Application, LECNet respectfully states:

I. LECNET, INC.

LECNet is a Mississippi corporation with principal offices located at 700 South West Street, Suite 210, Jackson Mississippi 39201. LECNet is certificated as a competitive provider of interexchange telecommunications services in Missouri pursuant to the Commission's Order Approving Interexchange Certificate of Service Authority in Case No. TA-94-229 issued May 31, 1994. LECNet currently does not serve any interexchange customers in Missouri. Further information concerning LECNet's authorization as a Missouri corporation was filed with the

Commission with LECNet's Application in Case No. TA-94-229, and is incorporated by reference herein.

III. REQUEST TO CANCEL CERTIFICATE AND TARIFF

As stated above, LECNet requests cancellation of its interexchange certificate and tariff because LECNet has no customers and does not intend to seek or serve customers under this certificate. Accordingly, LECNet respectfully requests the Commission cancel its certificate to provide competitive interexchange telecommunications services in Missouri, issued by Commission Order in Case No. TA-94-229 (May 31, 1994), and LECNet's current IXC tariff. LECNet requests that this cancellation be effective as soon as possible.


IV. PUBLIC INTEREST CONSIDERATIONS
