ORDER GRANTING MOTION TO CONSOLIDATE

On November 10, 1999, Southwestern Bell Telephone Company (SWBT) filed a complaint against Mid-Missouri Telephone Company (Mid-Missouri). Subsequently, on December 30, 1999, SWBT filed separate complaints against Chariton Valley Telephone Corporation (Chariton Valley) and against Seneca and Goodman Telephone Companies (Seneca-Goodman). All three complaints allege that respondent phone companies have improperly cut off SWBT's 800 MaxiMizer traffic. Mid-Missouri, Chariton Valley and Seneca-Goodman have separately answered SWBT's complaint and each has filed a motion asking the Commission to dismiss SWBT's complaint.

On January 26, 2000, SWBT filed a Motion to Consolidate and to Schedule an Early Prehearing Conference in each of the three cases. Prior to SWBT having filed its motion to consolidate, each of the respondent phone companies filed pleadings indicating their consent to the consolidation of SWBT's complaints against all of the respondent phone companies.

SWBT's Motion to Consolidate indicates that all three of the complaints present common questions of law and fact. Indeed, the complaints are nearly identical and the relief that SWBT seeks from the Commission in each case is identical. SWBT's motion indicates that counsel for SWBT has discussed consolidating these three complaints with counsel for each of the respondents. The motion indicates that consolidating these cases would be the most efficient way to handle them and that all consented to consolidation.

Upon review of these matters, the Commission concludes that common questions of law and fact will likely be presented in these proceedings. The Commission further concludes that consolidation of these proceedings will result in the most efficient use of the Commission's resources and that no party will be prejudiced by consolidation of these proceedings.

IT IS THEREFORE ORDERED:

- 1. That Case Numbers TC-2000-401 and TC-2000-402 are consolidated with and into Case Number TC-2000-325.
- 2. That Case Number TC-2000-325 is designated as the lead case and that hereafter all pleadings, briefs and correspondence regarding the consolidated cases shall be filed in the lead case.

3. That this order shall become effective on February 14, 2000.
