2. Pursuant to 4 CSR 240-2.060(1)(L), Applicant states that it has no annual report or assessment fees overdue.

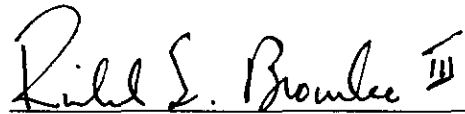
