

TO CANCEL CERTIFICATE OF SERVICE AUTHORITY**

COMES NOW FaciliCom International, LLC ("FaciliCom"), by and through its attorneys and, pursuant to 4 CSR 240-2.060(1), respectfully requests the Missouri Public Service Commission ("Commission") to Cancel its Certificate of Service Authority. In support of its Application, FaciliCom states as follows:

1. FaciliCom is a certificated interexchange carrier in Missouri with its principal place of business located at 1919 S. Highland Avenue, Suite 129-D, Lombard, Illinois 60148. FaciliCom was granted a Certificate of Service Authority in Case No. TA-98-323 on April 27, 1998. FaciliCom's Certificate to Transact Business as a Foreign Corporation was filed in that docket and is incorporated herein by reference.

2. Due to a change in business plans, FaciliCom requests the Commission to cancel its Certificate of Service Authority since FaciliCom does not intend to provide telecommunications services in the state of Missouri in the future.




