**APPLICATION TO CANCEL  
CERTIFICATE OF SERVICE AUTHORITY AND TARIFFS**

COMES NOW NXLD Company, d/b/a Nextel Long Distance ("NXLD"), through its undersigned counsel, and pursuant to 4 CSR 240-2.060 and § 392.410(5), RSMo 2000, respectfully requests the Missouri Public Service Commission ("Commission") to cancel its Certificate of Service Authority and Tariff. In support of its Application, NXLD states as follows:

1. NXLD is a Delaware corporation with principal offices located at 2001 Edmund Halley Drive, Reston, VA 20191. The Commission issued NXLD a Certificate of Service Authority to provide intrastate interexchange telecommunications services within the state of Missouri in Case No. TA-98-560 (July 31, 1998).

2. NXLD's certificate of authority to do business and registration of fictitious name from the Missouri secretary of state were provided in Case No. TA-98-560. Pursuant to 4 CSR 240-2.060(G), NXLD requests that the certificate and registration be incorporated by reference herein.

3. NXLD does not currently have any customers in the state of Missouri and, as its business plans have changed, NXLD no longer intends to provide telecommunications service in Missouri. Accordingly, NXLD does not have to notify anyone regarding discontinuance of service in Missouri.

4. NXLD does not have any pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of the application. NXLD does not, to the best of its knowledge, have any overdue annual reports or assessment fees.



6. Cancellation of NXLD's Certificate of Service Authority and tariffs is not detrimental to the public interest. The public will not be harmed by NXLD's withdrawal because, as stated above, NXLD does not provide any telecommunications services to customers in Missouri, and thus, no customers will be affected. Furthermore, there are many other alternative telecommunications providers from whom Missouri residents can purchase interexchange telecommunications services.

**Conclusion**

WHEREFORE, NXLD Company d/b/a Nextel Long Distance respectfully requests the Commission to issue an order canceling its certificate of service authority and tariffs and granting such other relief as is reasonable in the circumstances.
