### ORDER DIRECTING FILING

On June 26, 2000, WORLDxCHANGE Communications, Inc. (WCI) filed an application requesting the Commission grant it a certificate of service authority to provide interexchange telecommunications services within the state of Missouri and to classify the company and its services as competitive.

Commission rule 4 CSR 240-2.060(1)(K) requires that all applications include:

"A statement indicating whether the applicant has any pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of the application."

In addition, Commission rule 4 CSR 240-2.060(1)(L) requires that all applications provide a statement that "no annual report or assessment fees are overdue." Neither of these statements was included in WCI's application.

WCI's application fails to comply with Commission rules 4 CSR 240-2.060(1)(K) and (1)(L) and is, therefore, deficient. WCI shall be

directed to comply with Commission rules 4 CSR 240-2.060(1)(K) and (1)(L), or seek a variance of the rules.

#### IT IS THEREFORE ORDERED:

- 1. That WORLDxCHANGE Communications, Inc., shall comply with Commission rules 4 CSR 240-2.060(1)(K) and (1)(L) no later than 4 p.m. on or before August 4, 2000.
  - 2. That this order shall become effective on July 31, 2000.
