STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its staff recommendation respectfully states:

1. In the attached Memorandum, which is labeled Appendix A, the Staff recommends that the Commission issue an order to cancel LECNet's certificate of service authority and accompanying tariff.

2. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410, RSMo which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. 1989).

On April 28, 2000, LECNet, Inc. (LECNet), a competitive telecommunications company, filed an Application for Cancellation of Certificate and Tariff. LECNet was certificated by this Commission to provide interexchange telecommunications services on May 31, 1994, in Case No. TA-94-229. According to the Application, LECNet does not currently serve any interexchange customers in Missouri and has no plans to serve customers in the future.

The Telecommunications Department Staff (Staff) has no objections to LECNet's application and recommends that the Commission issue an order to cancel LECNet's certificate of service authority and accompanying tariff at its earliest convenience. The Staff is unaware of any other filing which affects or which would be affected by this proposal.
