WHEREAS, on the 24th day of May, 2007, it was represented to the Circuit Court of Cole County, Missouri, at the relation of Central Jefferson County Utilities, Inc. (hereinafter referred to as "Relator"), a corporation, in its Petition for Writ of Review, a copy of which is attached hereto, that the Public Service Commission of the State of Missouri (hereinafter referred to as "Respondent") issued a Report and Order on February 8, 2007, effective February 28, 2007, in the matter entitled:

Case No. SO-2007-0071, et al.; In the Matter of the Application of Central Jefferson County Utilities, Inc., for an Order Authorizing the Transfer and Assignment of Certain Water and Sewer Assets to Jefferson County Public Sewer District and in Connection Therewith, Certain Other Related Transactions.


WHEREAS, it was further reported to the Court that Respondent held a hearing as part of said proceeding in Jefferson City, Cole County, Missouri; that the principal office of Respondent is in Jefferson City, Cole County, Missouri; that Relator was a party to Respondent's Case No. SO-2007-0071; and that the Report and Order issued by Respondent in SO-2007-0071, et al. was unlawful, unjust, unreasonable, arbitrary, capricious, and unsupported by competent and substantial

evidence, all for the reasons set forth in Relator's Application for Rehearing and incorporated in its Petition for this Writ.

WHEREAS, it was further represented to this Court that on April 24, 2007, Respondent issued its order denying Relator's Application for Rehearing. Relator subsequently filed its Petition for Writ of Review setting forth the grounds upon which Relator contends the Report and Order is unlawful, unjust, unreasonable, arbitrary, capricious, and unsupported by competent and substantial evidence, within 30 days after the issuance of the order of Respondent denying Relator's Application for Rehearing.

IT IS, THEREFORE, ORDERED AND ADJUDGED by the undersigned Judge of the Circuit Court of Cole County, Missouri, that you, the Public Service Commission of the State of Missouri, certify fully and return to the Circuit Court of Cole County, Missouri, within thirty (30) days of the issuance of this Writ, a full, true and complete copy of the record in Case No. SO-2007-0071, et al., including transcripts of the evidence, all exhibits or copies thereof introduced, the pleadings filed, all orders issued therein, and all other records Respondent considered in said case, to the end that the Circuit Court of Cole County may adjudge upon the regularity of said proceedings, determine the lawfulness and reasonableness of the Report and Order, and make such further and other orders herein as may in equity be just and proper, and that the Court take no further action in such cause save compliance with this Writ of Review.
