**MOTION FOR ADDITIONAL TIME TO FILE TARIFF**

COMES NOW Net Talk.com, Inc. (“Applicant” or “Net Talk”), Applicant herein, by and through undersigned counsel, and respectfully requests additional time in which to submit its original tariff to the Commission in this matter. In support of this Motion, Net Talk states the following:

1. On February 4, 2011, the Commission issued its *Order Granting Application and Requiring Filing of Tariff* in this matter, which became effective February 14, 2011. The *Order* granted to Net Talk.com a certificate of service authority to provide basic local exchange telecommunications services within the State of Missouri.

2. The February 4, 2011 *Order*, per its title, directed Net Talk to “file a tariff detailing its services and charges no later than 30 days from the effective date of this order.” (Ordered Section 6.) That would be March 16, 2011.

3. Net Talk’s Missouri tariff is substantially complete. However, the tariff is not yet ready for submission to the Commission due to a few minor outstanding issues related to the tariff. Therefore, Net Talk respectfully requests additional time in which to file its proposed, original CLEC tariff.

4. Net Talk acknowledges that it cannot provide telecommunications services in Missouri until it has tariffs in effect. It is clearly in Net Talk's own best interest to file its original tariff as soon as possible, and Net Talk is endeavoring to make that filing.

5. Net Talk is not aware of other certificate orders of the Missouri Public Service Commission in which a specific deadline was established for the filing of a tariff. Typically, when a tariff has not been submitted at the time a certificate is granted, the Commission simply reminds the CLEC Applicant that before it provides service in Missouri, it must have in place an approved interconnection agreement and a tariff. However, no time deadline is established for submitting the tariff (or the interconnection agreement). See, for example, *RE: United Communications Systems, Inc. d/b/a Call One*, File No. LA-2011-0230, *Order Granting Certificates to Provide Basic Local, Nonswitched Local, and Interexchange Telecommunications Services* (Order issued February 25, 2011, effective March 7, 2011) – Page 4, last paragraph.

6. Net Talk submits that no injury or inconvenience would be caused to any other party, or to the public or the Commission, by allowing additional time for Net Talk to submit a tariff effectuating the certificate of service authority granted in the *Order* of February 4, 2011. It is clearly in Net Talk's best interest to file its proposed tariff as soon as possible, and it intends to do so and is working diligently to that end.

WHEREFORE, Net Talk.com, Inc. respectfully requests additional time, until April 30, 2011, in which to file its proposed, original tariff for approval by the Commission in this matter.
