## NOTICE REGARDING INCREASES IN WATER & SEWER CUSTOMER RATES

On February 19, 2014, the Missouri Public Service Commission (Commission) issued an Order under the provisions of its small utility rate case procedure, in which it approved an increase of \$25,521 in the Company's annual water service operating revenues and an increase of \$36,453 in the Company's annual sewer service operating revenues. In its Order, the Commission also approved new customer rates to be effective for service rendered on and after March 1, 2014. Set out at the end of this notice are tables that include monthly bill comparisons for both full-time and part-time residential customers. (For the RCV clubhouse, the new monthly minimum charges are the equivalent of 10 residential customers.)
