CORRECTIONS TO TESTIMONIES OF SBC MISSOURI WITNESS WESLEY POOL

Pursuant to the instructions of the Honorable Kevin Thompson during the hearing on the merits, Southwestern Bell Telephone L.P., d/b/a SBC Missouri hereby advises the Commission and all parties of the following clarifications and corrections regarding the pre-filed testimonies of SBC Missouri witness Wesley Pool:

Direct Testimony: The following sentence, which begins at page 30, line 26 and concludes on page 31, line 2, should be deleted in its entirety: SBC Missouri is not required nor shall it permit the collocation of stand-alone switches or enhanced services equipment.

Rebuttal Testimony: At page 3, line 25, the word "force" should be substituted in lieu of the word "frequency." Thus, the entirety of the sentence from lines 23 through 25 should read as follows: A Split Core Transducer is a device that is placed around a power cable to read the electro-magnetic force emitting from the cable.

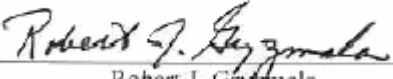
