**NOTICE OF APPLICATIONS AND OPPORTUNITY TO INTERVENE**

The Missouri Public Service Commission is required to give notice to all interexchange and local exchange telecommunications companies when an application is filed for a certificate of service authority or for competitive classification. §§ 392.361.2 RSMo 1994<sup>1</sup>.

The Commission must approve a certificate of service authority for the resale of interexchange telecommunication services or local exchange services if it finds that approving the certificate is in the public interest. § 392.440. The Commission may classify a company as competitive if it finds that all the telecommunications services the company offers are competitive services. § 392.361.3. The Commission waives application of the following statutes and Commission rules for competitive companies as authorized by Sections 392.361.5 and 392.420:



Each applicant has requested competitive classification, and has filed a proposed tariff. If the Commission's staff makes a favorable recommendation and no request for hearing is filed, the Commission will grant certificates of service authority and competitive classification to these applicants, and approve the applicants' proposed tariffs, without a hearing.
