

COMES NOW KCI Long Distance, Inc. ("KCI"), by and through its attorneys and, pursuant to 4 CSR 240-2.060(1), respectfully requests the Missouri Public Service Commission ("Commission") to Cancel its Certificate of Service Authority. In support of its Application, KCI states as follows:

1. KCI is a certificated interexchange carrier in Missouri with its principal place of business located at One Telergy Parkway, East Syracuse, New York 13057. KCI was granted a Certificate of Service Authority in Case No. TA-98-105 on November 19, 1997. KCI's Certificate to Transact Business as a Foreign Corporation was filed in that docket and is incorporated herein by reference.

2. Due to a change in business plans, KCI requests the Commission to cancel its Certificate of Service Authority since KCI does not intend to provide telecommunications services in the state of Missouri in the future.
