Excess Accumulated Deferred Income Tax (EADIT) Refunded to Customers

AVAILABILITY – This rate is available to any sewer customer within the Company's service area and adjacent to the Company's collecting sewers suitable for supplying the service requested.

DESCRIPTION – Rate T is designed to return to customers the remaining EADIT from the Stub Period (January 2018 through May 2021). As May 31, 2023, \$6,615,942 remains to be provided to customers. The rates below are designed utilizing the cost of service proposed in Case No. WR-2022-0303, and will be adjusted to reflect the final outcome of that case. This bill credit will return the unamortized balance to customers over six months. Six months after the effective date of this tariff, Rate T will be eliminated, and the Company will fill appropriate tariff sheets at that time to modify RT 32.

RATE COMPONENTS – In addition to the other charges provided for in the Company's tariffs, a separate charge for the EADIT Stub Period Refund will apply for service rendered on and after the effective date. This credit is calculated as a percentage of the customer's total bill, prior to any taxes.

All Customers: -2.7762% of the total bill

<u>RULES AND REGULATIONS</u> – The General Rules and Regulations set forth in this tariff shall govern the supply of service under this rate.
