Upon signing this Bill of Sale, the above-mentioned property shall belong exclusively to the Buyer, and the Seller shall have no further responsibility for, liability towards or interest in, said property.

The Seller hereby affirms that the above information about this property is accurate to the best of his/her knowledge, and by his/hersignature below certifies s/he is the lawful owner of the property with the ability to sell it as s/he sees fit.

The sale and transfer of this property is made with the following terms:

The well house with all of the supporting infrastructure shall be in sound working order with no unresolved maintenance issues at the time of sale. Buyer acknowledges at time of sale that no known unresolved issues exist with the exception of a leaking access cover on the large storage tank and waives the requirement for repair

# The following is a list of the equipment, land, easement, and assets currently held by the Carl R. Mills:

#### For the Water System:

Phase One Well Lot and the assets thereon, including: Well Pumps Water storage tank Building

All the piping infrastructure required to provide water service from the well to each residential lot within the Geographic Service Area.

#### Future Water System:

All undeveloped lots identified within the Geographic Service Area (Exhibit A) will be allowed to be connected to the water and sewer systems, and become assets of the Corporation, at no cost or impact to the Corporation. Per the Department of Natural Resources regulations, the cost to provide utility hookups (i.e., utility service to each lot) will be paid for by the Owner.
