ORDER RECOGNIZING CHANGE OF NAME AND APPROVING ADOPTION NOTICE

Harcourt Telco, L.L.C. (Harcourt) submitted a notification of registration of fictitious name on July 26, 1999, showing that it will be operating under the fictitious name, Maverix.com, Inc. Harcourt included with its filing a registration of fictitious name from the Missouri Secretary of State. Harcourt did not include an adoption notice nor did it file a tariff title page.

On August 16, 1999, the Missouri Public Service Commission (Commission) ordered that Harcourt file both an adoption notice and a tariff title page, each having an effective date no later than September 15, 1999. On September 14, 1999, Harcourt filed a notice of adoption of tariff and included a tariff sheet entitled "Original Adopted Title Sheet" (original sheet). The original sheet had an issue date of August 17, 1999, and an effective date of September 15, 1999. Although the Commission's order directed Harcourt to file both a title sheet and an adoption notice, Harcourt filed only the original sheet.

The Staff of the Commission (Staff) filed a memorandum on September 30, 1999. Staff stated that it contacted Harcourt to advise

that the original sheet was deficient. Staff stated that at its request,
Harcourt filed a substitute tariff sheet entitled "Original Adoption
Notice Page" on September 17, 1999.

On September 27, 1999, the Commission issued a notice regarding filing, stating that Harcourt did not need to file a tariff title page. In its memorandum, Staff stated that it believed that Harcourt's amended adoption notice was in compliance with the Commission's order and recommended that the Commission in this order amend Harcourt's certificate of service authority to reflect the name change and approve the following tariff page:

Harcourt Telco, L.L.C. d/b/a Maverix.com, Inc. Tariff MO P.S.C. No.1 Original Adoption Notice Page

In its memorandum, Staff stated that it had reviewed Harcourt's filing and had no objection to its approval. Staff recommended that the name change be recognized and the adoption notice approved to become effective.

The Commission has reviewed Harcourt's filing, the adoption notice, and Staff's recommendation, and finds that the change of name should be recognized. The Commission further finds that the adoption notice reflecting the change of name in its certificate of authority should be approved.

IT IS THEREFORE ORDERED:

1. That the change of name from Harcourt Telco, L.L.C to Maverix.com, Inc. is acknowledged.

- 2. That the adopted title sheet denominated Mo. P.S.C. No. 1, Original Adopted Title Sheet is approved.
 - 3. That this order shall become effective on November 1, 1999.
 - 4. That this case may be closed on November 2, 1999.
