ORDER ACCEPTING REVISION TO APPENDIX A ATTACHED TO STAFF'S MOTION TO SUSPEND TARIFF

On January 19, 2000, Southwestern Bell Telephone Company (SWBT) filed revised tariff sheets (Tariff No. 200000641) for the purpose of eliminating the requirement which the Commission imposed in Case No. TO-91-163 that SWBT use the Net Incremental Separated Method to calculate the end user common line contributions of Plexar®-Custom arrangements. The tariff filing had an effective date of February 19, 2000. On February 9, 2000, the Staff of the Missouri Public Service Commission (Staff) filed a motion to suspend the tariff for a sufficient period to hold a hearing on the tariff revision. Attached to the motion to suspend was Appendix A, a Staff memorandum. By order issued February 17, 2000, the Commission suspended the tariff until June 18, 2000.

On February 16, 2000, the Staff filed a revision to Appendix A requested that the Commission substitute the amended Appendix A for its original Appendix A. The request for substitution notes that, based upon information provided by SWBT, the Staff had stated in the original Appendix A that the multi-line business end-user common line

charge was \$3.50. Subsequent to the filing of the Motion to Suspend Tariff, SWBT advised Staff that the multi-line business end-user common line charge is \$7.19 and the single-line business end-user common line charge is \$3.50. Staff indicates that the amended Appendix A is being filed only to correct this erroneous statement of fact, and does not affect the Staff's position to seek suspension of the tariff.

The Commission has reviewed Staff's request to consider the amended Appendix A, which was filed on February 16, 2000, in lieu of the original Appendix A, which was attached to the Staff's February 9, 2000, Motion to Suspend Tariff, and finds that the request is reasonable and shall be granted.

IT IS THEREFORE ORDERED:

- 1. That the amended Appendix A, filed February 16, 2000, shall be substituted for the original Appendix A, which was attached to Staff's Motion to Suspend Tariff and was filed on February 9, 2000.
 - That this order shall become effective on March 30, 2000.
