# **ORDER GRANTING EXTENSION OF TIME TO FILE**

On February 20, 2001, the Staff of the Missouri Public Service Commission (Staff) filed a Request for Extension of Time to file its recommendation as required by the Commission's Order Directing Filing issued on December 21, 2000. The Commission directed Staff to file its recommendation no later than February 20, 2001. Staff stated that it is currently negotiating with Foxfire Utility Company and believes that a settlement agreement may be reached within the next week.
