ORDER GRANTING EXTENSION OF TIME TO FILE

On February 20, 2001, the Staff of the Missouri Public Service Commission (Staff) filed a Request for Extension of Time to file its recommendation as required by the Commission's Order Directing Filing issued on December 21, 2000. The Commission directed Staff to file its recommendation no later than February 20, 2001. Staff stated that it is currently negotiating with Foxfire Utility Company and believes that a settlement agreement may be reached within the next week. Therefore, Staff requested that the time for filing its recommendation be extended from February 20, 2001 until February 27, 2001.

The Commission finds that the request to extend the time for filing of Staff's recommendation is reasonable and will grant Staff's request.

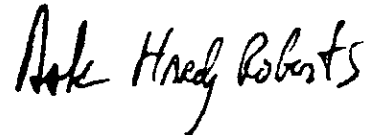
IT IS THEREFORE ORDERED:
