My name is Andrew Haer. My wife and I purchased a property at 29688 White Deer Lane, La Plata, MO 63549, on March 20, 2015. It has recently been brought to our attention that our residence and farming operation may be affected by the transmission power lines. We were never contacted face to face or given any form of written notification that this property was in the pathway of these power lines. Myself and my wife are not members of the neighbors united and were not informed of this potential conflict of interests prior to closing on this property. It was recently brought to our attention that the power lines will be cutting across a large portion of our farming operation. We are in need of further information on the exact route of the power lines, the intended use of our ground, how this will disrupt our farming operation and way of life.
