ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF

On March 10, 2000, PF.Net Network Service Corp., formerly PF.Net, LLC (PF.Net or Company), submitted a letter and an adoption notice to the Commission that requested the Commission's recognition of the Company's change of name. The adoption notice is denominated MO P.S.C. Tariff No. 1, Original Page i. An accompanying letter and materials presented that the Company had recently completed a *pro forma* reorganization involving the creation of a holding company above PF.Net and changed its form of organization from a limited liability company to a Delaware corporation. The old and new corporate structures were presented in organizational charts.

The materials submitted by the Company also included the Missouri Secretary of State's certificate of good standing under the new name. The requested effective date for the adoption notice tariff sheet is April 10, 2000. The Company is authorized to provide interexchange and local exchange telecommunications' services in the State of Missouri pursuant to the Commission's July 26, 1999, Order in Case No. TA-99-603.

The Commission's Staff reviewed the application and filed a Recommendation and Memorandum on March 27, 2000. The recommendation states

that Staff has no objection to the proposed adoption notice and recommends the Commission amend PF.Net's certificate of service authority to reflect the new company name. Staff recommended approval of the following tariff sheet to become effective April 10, 2000: PF.Net Network Service Corp., MO P.S.C. Tariff No. 1, Original Page i.

The Commission has reviewed the application, the tariff sheet and Staff's recommendation and finds that the change of corporate name should be recognized and that the adoption notice tariff sheet should be approved to become effective on April 10, 2000.

IT IS THEREFORE ORDERED:

1. That the change of name for PF.Net Network Service Corp., formerly PF.Net, LLC, is recognized.

2. That the adoption notice filed as a tariff sheet by PF.Net Network Service Corp., formerly PF.Net, LLC, on March 10, 2000, Tariff File No. 200000821, is approved to become effective on April 10, 2000. The tariff sheet approved is:
