ORDER DIRECTING FILING

on April 19, 2001, Foxfire Utility Company filed a motion requesting approval of its tariffs sheets with less than thirty day effective date. These tariff sheets were filed pursuant to the Commission's April 17, 2001, order granting Foxfire a certificate of public convenience and necessity. The proposed tariff sheets bear an effective date of May 19, 2001. Foxfire requested that the Commission approve its tariff pages to be effective on April 27, 2001, or as soon thereafter as the Commission will allow.

The Commission finds that it is necessary to determine when the Staff will be able to review the proposed tariff sheets and file its recommendation with the Commission. Therefore, the Commission will direct Staff to file a report stating when the Staff will be able to review the proposed tariff sheets and file its recommendation with the Commission, and if Staff can file its recommendation with the Commission in time for the Commission to issue an order regarding the proposed

tariff sheets less than 30 days from the date the tariff sheets were filed.

IT IS THEREFORE ORDERED:

- 1. That the Staff of the Commission shall file its response indicating whether it can review the proposed tariff sheets on an expedited basis and, if so, when Staff's recommendation can be filed. Staff shall file its response to this order no later than May 1, 2001.
 - 2. That this order shall become effective on April 30, 2001.
