## ORDER MAKING ALLTEL A PARTY

Southwestern Bell Wireless, Inc. (SWBW) filed its Application with the Missouri Public Service Commission (Commission) on February 8, 2000, for approval of an interconnection agreement (Agreement) between SWBW and ALLTEL Communications Services Corporation (ALLTEL) under the federal Telecommunications Act of 1996 (the Act).


Although ALLTEL is a party to the agreement, it did not join in the application. The Commission will make ALLTEL a party to this case. The order directing notice issued by the Commission on February 9, 2000 incorrectly stated that SWBW filed a joint application and thus failed to make ALLTEL a party.

**IT IS THEREFORE ORDERED:**

1. That ALLTEL Communications Services Corporation is made a party to this case.

2. That this order shall become effective on March 10, 2000.

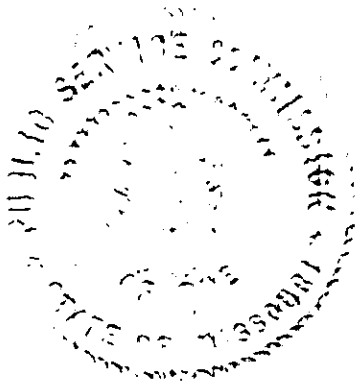
