ORDER GRANTING MOTION TO RESCHEDULE

On March 3, 2000, the Staff of the Missouri Public Service Commission (Staff) filed with the Commission its motion to suspend the proposed tariff sheets of One Call Communications, Inc. d/b/a OPTICOM (OPTICOM) which was granted on March 14, 2000.

In the order granting the suspension of tariff, the Commission, inter alia, set an intervention date of April 3, 2000, and also ordered the parties to file their procedural schedule the same day.

On March 29, 2000, OPTICOM filed its motion to reschedule the date upon which to file the procedural schedule. OPTICOM correctly pointed out that until the Commission rules on any applications to intervene, the number of parties in this case, their issues and schedules, will not be known. Thus, OPTICOM stated, until all the parties have been joined, a meaningful procedural schedule cannot be agreed to and filed, so the date upon which to file the procedural schedule should be extended.

One of the alternatives which OPTICOM suggested was that the Commission reschedule the time for filing of the procedural schedule to a date twenty (20) days after the Commission rules on any applications

to intervene. The Commission, with a slight modification to this alternative, will order the rescheduling of the time for the filing of the procedural schedule until twenty (20) days after the intervention date.

IT IS THEREFORE ORDERED:

- 1. That the parties shall file a procedural schedule no later than 3:00 p.m. on April 24, 2000. The procedural schedule shall include dates for the filing of testimony and for an evidentiary hearing.
 - 2. That this order shall become effective on April 10, 2000.
