#### ORDER ESTABLISHING TIME FOR FILING OF RECOMMENDATION

Advanced Communications Group, Inc. (ACG) and ACG's wholly owned Missouri operating subsidiaries, Feist Long Distance Service, Inc. and Telecom Resources, Inc. d/b/a TRINetwork, Inc. (ACG Subsidiaries), filed a Joint Application with the Commission on August 16, 1999, for Commission approval of a plan to transfer control of the ACG Subsidiaries to Ionex Telecommunications, L.L.C. (Ionex). The transfer of control would be accomplished by the purchase of all outstanding shares of the ACG Subsidiaries by Ionex. In order that the planned transfer of control not be delayed, ACG and ACG Subsidiaries request that the Commission approve their application effective no later than October 31, 1999.

So that the Application may be considered expeditiously, the Staff of the Public Service Commission will be directed to file its recommendations regarding approval or rejection of the Application no later than October 1, 1999. The Office of the Public Counsel may file its recommendations regarding the Application on the same date.



#### IT IS THEREFORE ORDERED:

- 1. That the Staff of the Public Service Commission shall file its recommendations regarding approval or rejection of the Joint Application of Advanced Communications Group, Inc., Feist Long Distance Service, Inc. and Telecom Resources, Inc. d/b/a TRINetwork, Inc., no later than October 1, 1999.
  - 2. That this Order shall become effective on August 30, 1999.
