
1. The Company has main offices in Missouri located at 229 Millwell Drive, Maryland Heights, Mo 64043.



(6) The Company is legally, financially, and technically qualified to provide video service.

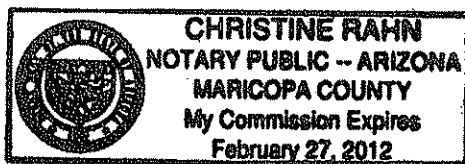
