

ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF

On March 14, 2000, Maverix.net, Inc., formerly Maverix.com, Inc. d/b/a Maverix.net, Inc. (Company), submitted a letter and an adoption notice to the Commission that requested the Commission's recognition of the Company's change of name. The adoption notice is denominated Missouri P.S.C. No. 1, Original Adoption Notice Page. Accompanying materials included the Missouri Secretary of State's amended certificate of authority under the new name. The requested effective date for the adoption notice tariff sheet is April 28, 2000. The Company is authorized to provide interexchange and telecommunications service in the State of Missouri pursuant to the Commission's March 8, 2000, Order in Case No. TA-2000-98.

The Commission's Staff reviewed the application and filed a Staff Recommendation and Memorandum on March 27, 2000. The recommendation states that Staff has no objection to the proposed adoption notice. The Staff recommends the Commission amend the Company's certificate of service authority to reflect the new name and approve the following tariff sheet to become effective April 28, 2000: Maverix.net, Inc., Missouri P.S.C. No. 1, Original Adoption Notice Page.

The Commission has reviewed the application, the tariff sheet and Staff's recommendation and finds that the change of corporate name should be recognized and that the adoption notice tariff sheet should be approved to become effective on April 28, 2000.

IT IS THEREFORE ORDERED:

1. That the change of name for Maverix.net, Inc., formerly Maverix.com, Inc. d/b/a Maverix.net, Inc., is recognized.

2. That the adoption notice filed as a tariff sheet by Maverix.net, Inc., formerly Maverix.com, Inc. d/b/a Maverix.net, on March 14, 2000, Tariff File No. 200000827, is approved to become effective on April 28, 2000. The tariff sheet approved is:
