ORDER APPROVING TARIFF

The Commission granted Camarato Distributing, Inc. (Camarato) a certificate of service authority to provide basic local exchange and interexchange telecommunications services in Missouri on May 20, 1999. The order directed the company to file tariff sheets reflecting the rates, rules, and regulations it will use and the services it will offer, and provided that Camarato's certificate would become effective concurrent with the effective date of the company's proposed tariffs. The order temporarily waived the filing of a 45-day tariff as required by 4 CSR 240-2.060(4)(H) until Camarato entered into a Commission-approved interconnection agreement that enabled it to provide basic local services. The Commission also ordered Camarato to file tariff sheets for approval no later than 30 days after the Commission approved the required interconnection agreement.

Camarato's interconnection agreement with GTE Midwest Incorporated was approved by the Commission on February 2, 1999, in Case No. TO-99-210. Camarato's interconnection agreement with SWBT is pending with the Commission in Case No. TO-2000-227. Camarato filed

the required tariff sheets on August 16, 1999, with an effective date of September 30, 1999. Camarato extended the effective date of its tariff to October 28, 1999. Camarato filed substitute sheets September 27, 1999.

The Commission's Staff reviewed the tariff sheets and filed a memorandum on October 8, 1999. Staff stated that Camarato proposes to offer prepaid basic local exchange service on a resale basis. Staff states that Camarato's tariff includes provisions for 911, discontinuance of service, Caller ID, Call Trace, directory listings, and promotional offerings. Staff indicates that Camarato's tariff is similar to other tariffs approved by the Commission for similar services.

Staff stated that it believes Camarato's proposed tariff complies with the Commission's orders. Staff stated that it has no objection to the Commission approving Camarato's tariff sheets as amended.

The Commission has reviewed Camarato's proposed tariff and Staff's recommendation and finds that the tariff details the services and pricing it proposes to offer. The Commission finds that the proposed tariff should be approved as amended to become effective on October 28, 1999.

IT IS THEREFORE ORDERED:

1. That the tariff filed by Camarato Distributing, Inc., on August 16, 1999, is approved as amended to become effective on October 28, 1999. The tariff approved is:
