#### ORDER GRANTING LEAVE TO FILE 1999 ANNUAL REPORT

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On June 1, 2000, Feist Long Distance, Inc., now known as Ionex Communications, Inc. (Feist), <sup>1</sup> filed a Motion for Leave to File 1999 Annual Report, requesting that its annual report, which was filed along with the motion, be accepted for filing out of time. Feist states that due to administrative oversight and matters associated with Ionex Telecommunications, Inc.'s acquisition of Feist in November 1999, Feist inadvertently failed to timely file its 1999 annual report by the April 15, 2000, deadline.

The Commission finds that good cause exists to permit Feist to file its annual report out of time, and the Commission will grant the company's Motion for Leave to File Annual Report Out of Time.

<sup>&</sup>lt;sup>1</sup> Ionex Telecommunications, Inc. (Ionex Communications, Inc.'s parent company) acquired Feist Long Distance, Inc., in November 1999. Feist has since changed its name to Ionex Communications, Inc. The Commission approved the name change of Feist to Ionex Communications, Inc., in Case No. TO-2000-518.

#### IT IS THEREFORE ORDERED:

- 1. That the Motion for Leave to File 1999 Annual Report, filed June 1, 2000, by Feist Long Distance, Inc., now known as Ionex Communications, Inc., is granted. The annual report deadline requirement of 4 CSR 240-10.080 is waived, permitting the filing of the 1999 annual report of Feist Long Distance, Inc., now known as Ionex Communications, Inc., on June 1, 2000.
  - 2. That this order shall become effective on June 23, 2000.
  - 3. That this case may be closed on June 26, 2000.
