ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."


On June 14, 2000, 1-800-RECONEX, Inc., filed a motion with the Commission requesting permission to file its 1999 annual report out of time. 1-800-RECONEX, Inc., included its 1999 annual report with its motion. 1-800-RECONEX, Inc., stated in its motion that it "failed to file the Annual Report [in a timely manner] due to its mistake in assessing the correct due date." 1-800-RECONEX, Inc., stated that it mistakenly believed that April 30 was the date the report was due to the Commission. No objections to 1-800-RECONEX, Inc.'s motion were received.

The Commission finds that good cause exists to permit filing of 1-800-RECONEX, Inc.'s annual report out of time, and the Commission will grant 1-800-RECONEX, Inc.'s motion for leave to file its annual report out of time.

IT IS THEREFORE ORDERED:

1. That 1-800-RECONEX, Inc.'s June 14, 2000, motion requesting permission to file its annual report out of time is granted.
2. That the annual report deadline requirement of 4 CSR 240-10.080 is waived and the filing of 1-800-RECONEX, Inc.'s annual report on June 14, 2000, is approved.
3. That this order shall become effective on July 11, 2000.
4. That this case may be closed on July 12, 2000.

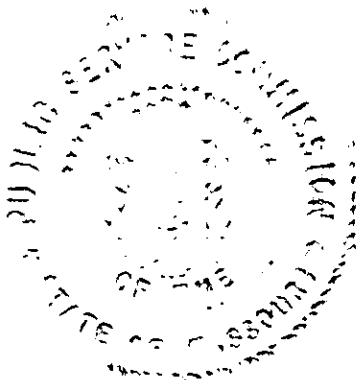
