ORDER GRANTING LEAVE TO AMEND APPLICATION

Teligent Services, Inc. (TSI) filed an application on March 17, 2000, for a certificate of service authority to provide basic local exchange and local exchange intrastate telecommunications services in the state of Missouri and to classify said services and company as competitive. The proposed tariff filed with TSI's application had an effective date of May 1, 2000. TSI has filed several extensions of the effective date, most recently extending that effective date to July 26, 2000.

On May 11, 2000, TSI filed its Motion for Leave to Amend Application pursuant to 4 CSR 240-2.080(21). TSI noted that the rules of the Commission had been revised or rescinded and the list of waivers requested by the company in its application was now out of date. Therefore, TSI requested leave to amend paragraph 14 of its application by interlineation to reflect the updated list of standard waivers of specific statutes and rules identified. TSI requested that the Commission suspend, waive or modify the application of the following rules and statutory provisions:

- 392.210.2 - System of accounts
- 392.270 - Property valuation
- 392.280 - Depreciation rates
- 392.290.1 - Issuance of securities
- 392.300.2 - Stock ownership
- 392.310 - Issuance of stock and bonds
- 392.320 - Stock dividends
- 392.330 - Issuance of securities; debts and notes
- 392.340 - Reorganization(s)

Commission Rules

- 4 CSR 240-10.020 - Depreciation fund income
- 4 CSR 240-30.010(2)(C) - Posting of rate schedules at
central offices
- 4 CSR 240-30.040 - Uniform system of accounts
- 4 CSR 240-32.030(4)(C) - Filing of exchange boundary maps
- 4 CSR 240-33.030 - Inform of lowest price
- 4 CSR 240-35 - Reporting of bypass

These statutes and regulations for which TSI request waiver are included in the standard statutes and regulations typically waived by the Commission for competitive telecommunications services. TSI has not requested waiver of Section 392.240(1) or subsection 2 of Section 392.290, which are also part of the standard statutes typically waived by the Commission for competitive telecommunications companies. No objections to TSI's Motion for Leave to Amend were received.

The Commission has reviewed TSI's Motion for Leave to Amend Application and will grant TSI leave to amend its application.

IT IS THEREFORE ORDERED:

1. That the Motion for Leave to Amend Application filed by Teligent Services, Inc. on May 11, 2000, shall be granted.

2. That this order shall become effective on July 17, 2000.
