

**ORDER CANCELING CERTIFICATE**

On June 29, 2000, MiComm Services, Inc. ("MiComm"), filed its application requesting that the Commission cancel the conditional certificate of authority granted to it in Case No. TA-98-93. MiComm stated that it had not commenced service in the state of Missouri and does not have any customers in the state. MiComm further stated that it does not conduct any business in the state of Missouri.

On July 5, 2000, the Staff of the Missouri Public Service Commission (Staff) filed its recommendation that the Commission grant the application. Staff states that the certificate granted MiComm was conditional on the filing of a tariff and that MiComm has never filed a tariff.

The Commission has reviewed the application and the Staff recommendation and finds that the conditional certificate of service authority granted to MiComm in Case No. TA-98-93 shall be canceled.

**IT IS THEREFORE ORDERED:**

1. That the conditional certificate of authority granted in Case No. TA-98-93 to MiComm Services, Inc., shall be canceled on July 25, 2000, unless otherwise ordered by the Commission.

2. That this case may be closed on July 26, 2000.


