

**ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME**

On June 16, 2000, Call Manage, Inc. (Call) filed with the Missouri Public Service Commission (Commission) both its 1999 annual report and its motion for leave to file its annual report out of time.

Pursuant to Commission Rule 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year<sup>1</sup>."

Call stated that it was an interexchange telecommunications company authorized by the Commission to operate in the state of Missouri. Call stated that it did not submit its 1999 annual report by April 15, 2000, because of a misunderstanding of its responsibility to do so, given that Call has no assets, liabilities or income for 1999.

Call requested that the Commission grant its motion for leave to file its annual report out of time and accept its 1999 annual report.

<sup>1</sup> April 15, 2000, was on a Saturday, thus effectively making the due date the following Monday, i.e., April 17, 2000.

Upon review of Call's motion and the official case file, the Commission finds that there is good cause to grant leave to Call to file its annual report out of time because of Call's misunderstanding of the rule regarding the filing of annual reports. Therefore, an order granting Call's motion to file its annual report out of time will be granted.

However, Call does not make it clear how its misunderstanding arose. Call cites the correct rule, i.e., Commission Rule 4 CSR 240-10.080(1), in its pleading. This rule makes no provision for exempting a regulated utility from filing an annual report if it has no assets, liabilities or income. It is impossible, then, from reading its pleading to determine exactly what Call misunderstood. Thus, Call is admonished to comply with known and required deadlines in the future.

**IT IS THEREFORE ORDERED:**

1. That Call Manage, Inc.'s motion for leave to file its annual report out of time shall be granted.
2. That this order shall become effective on June 30, 2000.

3. That this case may be closed on July 1, 2000.


