ORDER RECOGNIZING CHANGE OF CORPORATE NAME
AND FILING OF ADOPTION NOTICE

By letter dated and filed April 16, 1999 Four Seasons Water and Sewer Company (Four Seasons) filed two tariff sheets, each denominated an Adoption Notice, to reflect the change of corporate name to Lake Region Water & Sewer Company (Lake Region). Four Seasons requested an effective date of May 16, 1999, for the Adoption Notices. Four Seasons also provided the Commission a copy of the Certificate of Amendment from the Missouri Secretary of State executed by the Secretary on March 18, 1999, reflecting the name change.

The Commission has reviewed Four Seasons' filing and finds that the name change should be recognized. The Adoption Notices filed as revised tariff sheets are denominated as follows:

NO. 1, First Revised Sheet No. A, Canceling Original Sheet No. A, filed on April 16, 1999, and assigned tariff file number 9900805, as substituted, is approved for service on and after May 16, 1999.

3. That the Adoption Notice and revised tariff sheet for the corporate name Lake Region Water & Sewer Company denominated P.S.C. MO. NO. 1, First Revised Sheet No. A, Canceling Original Sheet No. A, filed on April 16, 1999, and assigned tariff file number 9900806, as substituted, is approved for service on and after May 16, 1999.

4. That this order shall become effective on May 16, 1999.

5. That this case may be closed on May 17, 1999.
