# ORDER ADOPTING POST-HEARING SCHEDULE AND ACKNOWLEDGEMENT OF TARIFF EXTENSION

An evidentiary hearing was held in the above-styled cases on October 12 and 13, 1999. On October 14, 1999, all of the parties above (Alma) filed a motion for approval of post-hearing schedule. Pursuant to Commission Rule 4 CSR 240-2.140, the Missouri Public Service Commission (Commission) adopts the briefing schedule set out in that motion, with one change, i.e., changing the date for filing the reply briefs.



The Commission acknowledges that Alma has voluntarily extended the effective dates of the tariffs in each of the above cases until February 15, 2000.

#### IT IS THEREFORE ORDERED:

- 1. That the parties herein shall submit their factual questions based solely on the testimony of Matthew Kohly to AT&T Wireless Services, Inc., and shall file nine (9) copies of the same with the Missouri Public Service Commission, and one (1) copy with each party, no later than 3:00 p.m. on October 23, 1999.
- 2. That AT&T Wireless Services, Inc. shall submit its responses to the factual questions to the requesting parties, and shall file nine (9) copies of the same with the Missouri Public Service Commission, and one (1) copy with each party, no later than 3:00 p.m. on November 2, 1999. AT&T Wireless Services, Inc. shall also certify that the answers are from Matthew Kohly or from a person who has adopted the position of Matthew Kohly in toto.
- 3. That the parties herein shall file their initial briefs no later than 3:00 p.m. on December 10, 1999.
- 4. That the parties herein shall file their reply briefs no later than 3:00 p.m. on January 4, 2000.

5. That this order shall become effective on November 5, 1999.


