

ORDER DIRECTING FILING

On February 1, 2000, Missouri State Discount Telephone (MSDT) filed an application with the Commission for approval of an interconnection agreement. However, there is some confusion regarding the proper name of the party which MSDT wishes to enter into the interconnection agreement with. The cover sheet to the application refers to an interconnection agreement between MSDT and ALLTEL Communications Telephone Company (ALLTEL). However, various other sections of the application packet refer to ALLTEL Communications or ALLTEL Communications Service Corporation. ALLTEL is directed to clarify its correct and complete name by 12:00 p.m. on April 20, 2000.

In addition, on February 16, 2000, the Commission issued an Order Directing Notice and Adding a Party in which ordered paragraph 2 states: "That ALLTEL Communications Company is made a party to this case." However, it appears that ALLTEL was not added to the service list. Therefore, the Commission will direct that a copy of the February 16, 2000, Order Directing Notice and Adding a Party, be sent to ALLTEL, along with a copy of the Staff recommendation and memorandum filed March 9, 2000. ALLTEL, or any other party, shall

have seven days, until 12:00 p.m. on April 20, 2000, to file a response to either the Order Directing Notice and Adding a Party or the Staff recommendation and memorandum.

IT IS THEREFORE ORDERED:

1. That ALLTEL Communications Telephone Company shall file by 12:00 p.m. on April 20, 2000, a pleading clarifying its correct and complete name.

2. That any party may file a response to the February 16, 2000, Order Directing Notice and Adding a Party, or the March 9, 2000, Staff recommendation and memorandum, no later than 12:00 p.m. on April 20, 2000.

3. That the Records Department of the Missouri Public Service Commission is directed to send a copy of the February 16, 2000, Order Directing Notice and Adding a Party, and the Staff recommendation and memorandum filed March 9, 2000, to ALLTEL Communications Telephone Company.

4. That the Records Department of the Missouri Public Service Commission shall add ALLTEL Communications Telephone Company, One Allied Drive, Little Rock, Arkansas 72202, to the service list.

5. That this order shall become effective on April 20, 2000.
