**ORDER CANCELING PREHEARING CONFERENCE**

On March 15, 2000, the Commission by order adopted a procedural schedule in this matter that provides for a prehearing conference on May 30, 2000. However, on April 20, 2000, Respondent Kansas City Power & Light Company (KCPL) moved to dismiss this case. Thereafter, on May 3, 2000, Complainant Maurice Banks late-filed his Direct Testimony. KCPL has not responded to Banks' attempt to late-file his testimony and Banks has not responded to KCPL's motion to dismiss.

The motion to dismiss has not yet been disposed of; neither has the Commission accepted Mr. Banks' belated filing. The parties, in the meantime, have not complied with the other dates set by the procedural schedule. In the present stance of this matter, there is no purpose to be served by convening a prehearing conference on May 30. Therefore, the Commission will suspend the procedural schedule previously adopted pending the further order of the Commission.

**IT IS THEREFORE ORDERED:**

1. That the prehearing conference previously set for May 30, 2000, is canceled.
2. That this order shall become effective on May 25, 2000.
