ORDER GRANTING APPLICATIONS FOR INTERVENTION

On May 18, 2001, Laclede Gas Company submitted to the Commission tariffs reflecting increased rates for natural gas service provided to customers in the Missouri service area of the Company. On June 7, 2001, the Commission acted to suspend the tariff through April 15, 2002. The Commission issued its <u>Suspension Order and Notice</u> on June 7, 2001, and directed all interested parties to file an application to intervene no later than June 27, 2001.

Timely intervention applications were filed by the Missouri Energy Group,¹ by the Paper Allied-Industrial, Chemical and Energy Workers Local No. 5-6, AFL-CIO, by Union Electric Company, d/b/a AmerenUE, and by the Missouri Industrial Energy Consumers.²

The Commission has reviewed the applications to intervene and finds that they are in compliance with Commission rule 4 CSR 240-2.075(4). The prospective intervenors have interests in this matter that are different from that of the general public and granting

the proposed interventions would serve the public interest. The Commission concludes that the applications for intervention described above should be granted.

IT IS THEREFORE ORDERED:

- 1. That the Application to Intervene by the Missouri Energy Group is granted.
- 2. That the Application to Intervene by the Paper Allied-Industrial, Chemical and Energy Workers Local No. 5-6, AFL-CIO is granted.
- 3. That the Application to Intervene by Union Electric Company, d/b/a AmerenUE is granted.
- 4. That the Application to Intervene by the Missouri Industrial Energy Consumers is granted.
 - 5. That this order shall become effective on July 13, 2001.
