ORDER APPROVING TARIFFS

On February 28, 2002, Laclede Gas Company filed tariff sheets designed to implement a weatherization program pursuant to the Unanimous Stipulation and Agreement. Laclede filed a substitute sheet on March 22 to correct a typographical error. The tariffs bear an effective date of March 31. The weatherization program will provide eligible customers with conservation, education, and weatherization measures, and help them to use energy more economically. Grants averaging about \$2000 will be made to customers, and the program is expected to provide assistance to about 150 customers a year.

On March 25, the Commission's Staff filed a Memorandum in which it recommended the Commission approve the tariffs. Staff stated that the tariffs comply with the stipulation and agreement, and the Commission's order approving that agreement. Staff stated that the tariffs were filed after discussion among Laclede, Staff, the Office of the Public Counsel, and the Department of Natural Resources. Staff stated that Laclede plans to

contract with Community Action Program Agencies to do the qualification, evaluation, and weatherization.

The Commission has reviewed the tariff filing and the Staff memorandum and has determined it to be in compliance with the parties' agreement and the Commission's order.

The Commission will approve the tariffs.

IT IS THEREFORE ORDERED:

1. That the following tariffs filed by Laclede Gas Company on February 28, 2002, and assigned Tariff File No. 200200710, are approved as substituted for service on and after March 31, 2002:
