

ORDER APPROVING TARIFF

By order issued on October 29, 1999, the Commission granted to JATO Operating Corp. (JATO) certificates of service authority to provide basic local exchange, local exchange and interexchange telecommunications services in Missouri. JATO filed a Local Exchange Telecommunications Tariff on November 30, with an effective date of January 14, 2000. JATO filed substitute tariff sheets on December 13, December 23, January 3 and January 5. The Commission's Staff reviewed the tariff sheets and filed a Staff Recommendation on January 6, recommending that the Commission approve them as amended by the substitute sheets.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets, as amended, conform to the Commission's Order of October 29, and should be approved to become effective on January 14, 2000.

IT IS THEREFORE ORDERED:

1. That the tariff filed by JATO Operating Corp. on November 30, 1999, and assigned tariff number 200000510, is approved as amended to become effective on January 14, 2000. The tariff approved is:

2. That the certificate of service authority granted to JATO Operating Corp on October 29, 1999, to provide local exchange telecommunications services shall become effective on January 14, 2000.
