Pursuant to 4 CSR 240-2.060(5) and 4 CSR 240-3.545(20), CenturyTel of Missouri, LLC respectfully requests that the Missouri Public Service Commission ("Commission") approve use of the fictitious name of CenturyLink.

CenturyTel of Missouri, LLC's approved tariffs are currently on file with the Commission. CenturyTel of Missouri, LLC is in compliance with Annual Report requirements, and is current with its Missouri USF and Commission assessments.

CenturyTel of Missouri LLC d/b/a CenturyLink is properly registered with the Missouri Secretary of State's office, and is "Active and in Good Standing" with that office. As required by 4 CSR 240-2.060(5)(B), evidence of registration of the fictitious name, CenturyLink, with the Secretary of State is attached.
