# **ORDER DIRECTING FILING**

This order directs the Commission's Staff to provide further information concerning the Commission's jurisdiction to proceed in this case.

The Commission desires that Staff identify the specific facts of this case that it relies upon and, in particular, how the status of the regulated telecommunications company is affected by the proposed transaction. Staff's arguments should show how Staff applies the jurisdictional statute(s) it relies upon and should not present mere recitals or bare conclusions.

Because the applicants did not object to the Commission's jurisdiction, Staff must also provide an explanation of the legal harm or the expense, burden, or other detriment if the Commission accepts jurisdiction over the matter presented.

Finally, the Commission will direct its Staff to file its recommendation regarding the merger in the event the Commission assumes jurisdiction.

### **IT IS THEREFORE ORDERED:**

1. That the Commission's Staff must file a supplement to its motion to dismiss no later than October 1, 2001, following the guidelines set forth in this order.

2. That this order will become effective on September 9, 2001.
