NOTIFICATION OF SATISFACTION OF COMPLAINT, OR IN THE ALTERNATIVE, REQUEST FOR PREHEARING CONFERENCE

COMES NOW M.L.M. Telecommunications, Inc., d/b/a Ameritel, Your Phone Company (M.L.M., M.L.M./Ameritel, or Respondent), by and through counsel, and for its Notice of Satisfaction of Complaint, or in the alternative, request for prehearing conference, states as follows:

- 1. M.L.M. Telecommunications, Inc. d/b/a Ameritel, Your Phone Company, acknowledges that it did erroneously commence providing service to customers in Missouri prior to filing and approval of its basic local service tariff and prior to filing and approval of a name change with the Commission. Respondent regrets its error in prematurely commencing service to Missouri customers and apologizes for compounding that error by not responding in a timely manner to Staff's inquiries as to the status of its tariff and fictitious name filings.
- 2. Subsequent to the service upon MLM of Staff's complaint, on January 31, 2003, M.L.M. submitted a request for approval of name change with the Commission to use the fictitious name Ameritel, Your Phone Company, and filed its initial basic local service tariff. The name change and initial tariff have been docketed in Case No. CN-2003-0266.
- 3. Even though M.L.M. erroneously began doing business in Missouri prior to filing its tariff and indicating its fictitious name of Ameritel, Your Phone Company, it has provided

services within the terms of the tariff and fictitious name that have now been filed and are currently pending Staff and Commission review. M.L.M. has also filed a Motion to Expedite consideration of the request for approval of name change and tariff in the interest of curing the deficiencies which were the subject of Staff's Complaint as soon as practicable. To the best of its knowledge, M.L.M. has now taken all appropriate steps it is aware of to resolve and satisfy Staff's complaint.

4. In the event Staff's Complaint is not satisfied, M.L.M. requests that the Commission establish a prehearing conference so that further discussions between M.L.M. and Staff can be held to determine what is required for satisfaction of the Complaint.

WHEREFORE, M.L.M. respectfully submits this notice of Satisfaction and requests that in the event Staff's Complaint has not been satisfied, the Commission schedule a prehearing conference in this matter.
